## 6th World Day for Decent Work

The Trade Union Confederation of the Americas - TUCA, invites all its affiliated institutions to celebrate, on October 07, the 6th World Day for Decent Work with the motto of "Building Workers' Power in the Americas".

On October 07, the trade union movement worldwide will celebrate, once again, the **World Day for Decent Work**. The American continent has been, over the last years, the region that has fought the most against the deteriorating quality of life of millions of workers, preventing international economic and financial crises to be used as pretext for the adoption of precarious working conditions.

**TUCA** has the goal of continuing to make America the continent that mobilizes the most and invites all its affiliated institutions and organizations so that, on October 07, the largest and most numerous activities in the world are held.

**TUCA** began the "**Continental Campaign of TUCA on Freedom of Association, Collective Bargaining and Trade Union Self-Reform**", with the goal of contributing to stimulating strategic goals of the Decent Work Agenda, as observed by the Declaration on Social Justice towards a Fair Globalization, of 2008, particularly in the defense and promotion of principles and rights of freedom of association and collective bargaining, pillars of decent work, expressed in ILO conventions.

The Continental Campaign has the goal of touching workers, unionists, politicians, businessmen and owners of public opinion means, regarding the need to respect and achieve the essential principles and rights of Conventions 87 and 98 to ease initiatives of strategic self reform of trade unions: rates of increase of unionization, the extension of coverage and increase of collective bargaining, a reinforcement of sector and territory structures, and highest levels of union unity.

Under the context of this campaign it is aimed to providing a greater support to the activities that the union movement is organizing to demand Decent Work on October 7. In order to achieve that, we encourage our affiliated and fraternal organizations to mobilize as many people as possible and organize more activities for the World Day for Decent Work.

## UGT discusses strategies with multinational companies

UGT's Department of Integration for the Americas held the International Seminar "**Trabalhadores e Trabalhadoras Construindo Estratégias Globais frente ao poder das Multinacionais**" (Workers Building Global Strategies against the power of Multinational Companies), on September 17 and 18, in SPaulo.

While opening the seminar, **Ricardo Patah**, national president of UGT, thanked the presence of Adriana Rosenzvaig, Regional Secretary of UNI Global Union Americas, **Victor Baez**, from the Trade Union Confederation of the Americas - TUCA, and spoke of the importance of holding this event, which will discuss the employment status of multinational companies workers, affirming that having knowledge of this information will allow the strengthening of UGT leaders in the fight against precarious work.

To **Sidney de Paula Corral**, holding this event was important to UGT's unionists since it gives room for knowledge of the international labour scenario. ## In Belo Horizonte, UGT makes a protest against Nissan

On September 26, UGT's State branch of Minas Gerais held a large protest in front of the Nissan Mizaki dealership, in downtown Belo Horizonte. Led by **Ricardo Patah**, UGT's national president, this protest was supported by 150 commerce workers and metallurgists.



"This movement is not against Nissan here in Brazil, it is, in fact, against Nissan USA, which does not allow its workers to join their respective trade unions".

"Our trade union central was looked up, not too long ago, to show solidarity and participate in events against Nissan in Brazil until our claims are answered. We already held an act in Curitiba, another one in Sao Paulo, and today we are holding one in Belo Horizonte", stated Ricardo Patah.

Metallurgists from UGT, who attended the 1st National Meeting of Metallurgists Unions of UGT, participated, along with commerce workers, in this act, which drew the attention of everyone who was passing by in the Dom Pedro II avenue, in front of the Nissan dealership.

Delson Oliveira, national secretary of UGT's Department of Metallurgists, said that "the fight of American workers is also the fight of Brazilians. He also said that it is "unacceptable that in the XXI century, a company as Nissan is to deny workers a trade union representation and collective bargaining, especially in the USA".

### The action of UGT in the regulation of outsourcing

UGT has attended all meetings, events and everything else that is related to the regulation of outsourcing. It is important for workers that this central is leading this fight, since there is no law to prohibit it, there is also not a law that regulates outsourcing, which can also lead to situations of precarious work, once businessmen consider outsourcing a way to increase their profit and not their competitiveness.

We cannot have a simplistic view of being against something that involves 12 million workers and is somehow consolidated as labour organization, but we cannot allow that labour organizations are disorganized.

We are wary to the possibility of vote of the Law Project 4330 in order to avoid that the clause that allows outsourcing in any activity of a company is approved. In this concern, UGT established its position against the outsourcing of a company's core activity, understanding that the activity that responds for the existence of the company cannot be distorted. It is not only about a trade union request, but still, a way to guarantee a productive model for our country.

It is essential to follow up the mobilization of all our colleagues, since there is an enormous interest of a quick vote of the law project 4330 and we cannot allow it to be approved the way it is. Therefore, opinion, protest and mobilization are essential.

### The number of children who work decreases

A new report by the International Labour Organization (ILO), marking progress against child labour, says that the global number of child labourers has declined by one third since 2000, from 246 million to 168 million. But even the latest improved rate of decline is not enough to achieve the goal of eliminating the worst forms of child labour by 2016 – agreed by the international community through the ILO.

**“We are moving in the right direction but progress is still too slow. If we are serious about ending the scourge of child labour in the foreseeable future, we need a substantial stepping-up of efforts at all levels. There are 168 million good reasons to do so,”** said ILO Director-General Guy Ryder.



The latest ILO estimates, published in the lead-up to the Global Conference on Child Labour, which takes place in Brasilia next month, show that most of the progress was made between 2008 and 2012, when the global number fell from 215 to 168 million.

More than half of the 168 million child labourers worldwide are involved in hazardous work. This is work that directly endangers their health, safety and moral development. The current number of children in hazardous work stands at 85 million, down from 171 million in 2000.

Hazardous work is often treated as a proxy for the Worst Forms of Child Labour, since children in hazardous work account for the overwhelming majority of those in the worst forms.

The report identifies a number of actions that have driven progress in the fight against child labour in recent years. Policy choices and accompanying investments in education and social protection appear particularly relevant to the decline in child labour.

Other actions include the political commitment of governments, the increasing number of ratifications of the two ILO child labour Conventions, sound policy choices and solid legislative frameworks.
